February 3, 2014 MURPHY, IDAHO

Present were Chairman Joe Merrick, Commissioner's Jerry Hoagland, and Kelly Aberasturi, Deputy Clerk Brook Russell, Tammie and Heath Hedges representing New Environment, LLC, David Bunker representing Branch Enterprises 7 Inc., JB Salutregui representing Baker Auction, Jon Brown with the Owyhee Avalanche, Ross Gruenwald and Craig Whitted.

Commissioner Hoagland made a motion to amend the agenda to include a letter of support for the Owyhee Cattlemen's Association. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to set the agenda as amended. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve a Certificate of Residency to the College of Southern Idaho for Megan Green. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve Certificates of Residency to the College of Western Idaho for Jason Carr, Veronica Sanchez, Evelyn Williams, and Amber Purvis. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve, sign and send to the BLM the 'Protocol for Coordination between BLM Boise District and Owyhee County'. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to appoint Steve Carlin to the Owyhee County Waterways Committee. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve the FY 2013 Annual Road and Street Financial Report and send to the Idaho State Controller. Seconded by Commissioner Aberasturi. Motion carried.

J.B. Salutregui with Baker Auction Company presented the Board with the contract for the 2014 Annual Homedale Consignment Sale that will be held on March 1, 2014. Mr. Salutregui explained that since the Sheriff Department will be selling items as well, Sheriff Grant's name will be added to the contract. Mr. Salutregui also explained that sale terms will be 10%, as in the past.

Commissioner Hoagland made a motion to approve and sign the contract for Baker Auction Company for the Auction to be held on March 1, 2014. Seconded by Commissioner Aberasturi. Motion carried.


