Waterway's Committee appointees Dave Ellis and Jerry Benson met with the Board to discuss what the expectations of the committee consisted of. Monthly meetings will be scheduled for them to meet with the Board. Bob Aldrich was unavailable, but had been in contact with Board members. Jerry Benson said a tour would be conducted to determine need. A meeting with the Owyhee County Waterways Deputies was discussed as well.

Kelly Aberasturi, recently appointed chairman of the Owyhee County Fair Board, discussed possible replacements for recently retired member David Rutan on the Board.

Discussion was held on the replacement of the arena fence at the fair grounds and putting an irrigation system in to irrigate the arena. Re-appointment of Fair Board members will be placed on next week's agenda.

Road District 3 Supervisor Dave Miller presented the proposal for road maintenance with Mountain Home Air Force Base for 2010. The proposed amount is \$28,402.65. Assessor Endicott presented a contractual agreement with Shewey, Vander Boegh & Associates for an industrial appraisal to be performed at U.S. Ecology of Idaho for 2010 in the amount of \$5,200. After moving out of executive session, Commissioner Freund made a motion to send a letter to Earll Excavators requesting a revised Surety Bond, and Memorandum Agreement authorizing signature for Silver Falcon Mining Inc. Commissioner seconded the motion. Hyer-aye, Freund-aye, Hoagland-aye.

The Board recessed for a meeting in Marsing on February 9<sup>th</sup> with the Owyhee Initiative Board.
