

OWYHEE COUNTY COMMISSIONERS MINUTES
JUNE 1, 2010
OWYHEE COUNTY COURTHOUSE
MURPHY, IDAHO

Present were Commissioner's Jerry Hoagland, and Richard Freund, absent was Commissioner Hyer who is recuperating in the hospital following an accident involving a horse, and Clerk Charlotte Sherburn.

Commissioner Hoagland called the meeting to order. Issues discussed to be put on the agenda were a road issue with Doug Hipwell, and cancellation of the June 8th Board meeting for lack of a quorum.

Commissioner Freund made a motion to amend the agenda to include the two items for consideration. Commissioner Hoagland seconded the motion. Freund-aye, Hoagland-aye.

Commissioner Freund made a motion to set the agenda, with a second from Commissioner Hoagland. Hoagland-aye, Freund-aye.

Commissioner Freund made a motion to approve the Board Minutes for the May 24th meeting. Commissioner Hoagland seconded the motion. Hoagland-aye, Freund-aye.

Commissioner Freund made a motion to approve the closeout of the 2006 Bureau of Homeland Security Grant Funds. The amount expended for emergency training, and equipment was \$136,338. The performance period for the grant was 7/1/2006 to 3/31/2010. Commissioner Hoagland seconded the motion. Hoagland-aye, Freund-aye.

Commissioner Freund made a motion to approve the Memorandum of Understanding for County/Welfare Combined Medical Applications. The agreement enables Owyhee County to get information on applicants, status that has applied for assistance through the Idaho Benefit Eligibility System. Commissioner Hoagland seconded the motion for approval. Hoagland-aye, Freund-aye.

Commissioner Freund made a motion to approve the Progress Report for the Idaho Commerce Department Block Grant for the Museum Complex. Included with the report was an invoice from Mussell requesting payment for \$3,885 for work on the complex. Commissioner Hoagland seconded the motion. Hoagland-aye, Freund-aye.

Commissioner Freund moved to approve a catering permit for Murphy Outpost Days to be held on June 4th through June 6th. Commissioner Hyer seconded the motion. Hoagland-aye, Freund-aye.

Deputy Belle Evans presented pending Indigent and Charity cases for review.
I.C. Case # 10-25 a lien was approved.
I.C. Case #10-17 approved applicant for payment of bills.
I.C. Case #10-19 approved applicant for payment of bills.

Commissioner Freund approved with a second from Commissioner Hoagland. Freund-aye, Hoagland-aye.

Commissioner Freund made a motion to cancel the Board meeting for June 8th due to a lack of a quorum of the Board. Commissioner Hoagland seconded the motion. Freund-aye, Hoagland-aye. Regular Board meetings will resume on June 14th.

Commissioner Freund made a motion to approve payment of all outstanding claims with the exception of one from the Coroner lacking a receipt for a credit card, and one from the Sheriff's office to Gus's Gas for fuel for patrol of the station near Bruneau set up by the Department of Agriculture. Commissioner Hoagland seconded the motion.
