

OWYHEE COUNTY COMMISSIONERS MINUTES
JULY 5, 2011
OWYHEE COUNTY COURTHOUSE MURPHY, IDAHO

Present were Commissioner's Jerry Hoagland, Joe Merrick, and Kelly Aberasturi, Clerk Charlotte Sherburn, and Treasurer Brenda Richards.

Commissioner Hoagland called the meeting to order. Commissioner Merrick made a motion to amend the agenda to include the repair of the roof at the Sheriff's office out to bid, and payment of bill for camera. Commissioner Aberasturi seconded the motion. Motion carried.

Commissioner Merrick made a motion to set the agenda as amended, with a second from Commissioner Aberasturi. Motion was unanimous.

Commissioner Merrick made a motion seconded by Commissioner Aberasturi to approve the Board Minutes as presented. Motion carried.

Commissioner Merrick made a motion to approve payment of all bills presented as well as do a demand payment to Quill Corporation for purchase of a camera for the OHV program in the amount of \$118.00. Commissioner Aberasturi seconded the motion. Motion carried.

Treasurer Richards presented a request for cancellation of personal property taxes on parcel no PP5901340 in the amount of \$35.17. The Hair Depot relocated the equipment to Caldwell. Commissioner Merrick made a motion to approve the cancellation, and the motion was seconded by Commissioner Aberasturi. Motion was unanimous.

Commissioner Aberasturi moved to approve the certificate of residency for tuition assistance to College of Western Idaho for Lynlee Lord. Commissioner Merrick seconded the motion. Motion carried.

Commissioner Merrick made a motion to put replacement of the roof at the Sheriff's office out to bid. Commissioner Aberasturi seconded the motion. Motion carried.

Doris Jewett requested the purchase of two new computers for the Probation Department. The funds will be taken out of the lottery trust. Commissioner Aberasturi made a motion to approve, with a second from Commissioner Merrick. Motion was unanimous.

Commissioner Merrick made a motion to recess as Board of County Commissioners and convene as the Board of Equalization to review property value appeals. Commissioner Aberasturi seconded the motion. Motion carried.

Roger & Jerri Nelson appeared to appeal the property values on Lot 56 and Lot 81 in Silver City. After considering the testimony given by the Nelson's and the Assessor's office Commissioner Aberasturi made a motion to table the matter until July 11th at 1:00 p.m. Commissioner Merrick seconded the motion. Motion carried.

Karlyne Landrum appeared to appeal the property values on parcel no. RPA020000030120A. After considering Ms. Landrum's testimony and that of the Assessor's office Commissioner Merrick made a motion to uphold the Assessor's valuation. Commissioner Aberasturi seconded the motion. Motion carried.

Kirk Oemig appeared to appeal the property values on parcel no. RPD0040014003A A. After considering testimony given Commissioner Aberasturi made a motion to table the matter until July 11th at 1:00 p.m. Commissioner Merrick seconded the motion. Motion carried.

Dan Thompson did not appear to give testimony on the appeal of parcel no. RPD0000222613. Commissioner Aberasturi made a motion to uphold the Assessor's valuation. Commissioner Merrick seconded the motion. Motion carried.

Elias Jaca appeared to appeal the property values on parcel no. RP01N03W2090000A. After considering Mr. Jaca's testimony and that given by the Assessor's office, Commissioner Merrick made a motion to lower the valuation from 6,085 to 3,815 due to a discrepancy in the acreage. Commissioner Aberasturi seconded the motion. Motion carried.

Commissioner Merrick made a motion to go out of Board of Equalization and reconvene as Board of County Commissioners. Commissioner Aberasturi seconded the motion. Motion carried.

There being no further business the Board moved to adjourn.
