Present were Commissioners Merrick and Aberasturi, Clerk Barkell, Deputy Clerk Russell, Sheriff Grant, Chief Deputy Assessor Gruenwald, Treasurer Richards, Paragon Consulting representative Mike Kaes, Bruneau Community Church members Duane and Linda McDowell and Sean Chaney with the Owyhee Avalanche. Commissioner Hoagland was absent.

Bruneau Community Church members Duane and Linda McDowell requested a reduction in building permit fees for a remodel at the church. Chairman Merrick informed Mr. McDowell to submit a formal letter requesting the reduction as well as a reason for the request. Commissioner Aberasturi made a motion to approve 3 Certificates of Residency to the College of Southern Idaho for Wyatt Wolfe, Belmin Badzic and Elizabeth Diaz. Seconded by Commissioner Merrick. Motion carried.


Commissioner Aberasturi made a motion to approve the order for the 2015 Abstract correction. Seconded by Commissioner Merrick. Motion carried.


