Commissioner Hoagland made a motion to go out of closed session. Seconded by Commissioner Aberasturi. Motion carried.


Murphy, Reynolds, Wilson (MRW) Fire Chief Wes Anderson met with the Board and requested the Sheriff's old Haz Mat trailer that is no longer in use. The Board explained they will research what funds the trailer was originally purchased with and get back to him. Mr. Anderson also requested \$16,000.00 for a 10% match for a grant received to purchase 20 SCBA's (4 at each station plus training and back up units), Commissioners requested a formal letter for the request. An ongoing conversation between Mr. Anderson and the Board is an issue regarding the driveway from Highway 78 to the firehouse. Mr. Anderson asked that the Board and or himself, pursue changing the route of the driveway for a more convenient driveway on MRW property. The Board explained they will discuss the issue and find answers from Assessor Endicott. The last issue Mr. Anderson brought forth was the possible help in paying for EMT training. Each individual training costs approximate \$800.00. The Board asked for a formal request.

Commissioner Hoagland made a motion to approve Resolution 2014-33; to close Bachman Road and Silver City Road for automobile travel, effective immediately due to icy, snow and weather conditions, until further action of the Board of Commissioners. Seconded by Commissioner Merrick. Opposed by Commissioner Aberasturi. Motion carried.

A coordination meeting was held at 1:30 pm with the BLM Boise District Office.

There being no further business the Board moved to adjourn.
