The Board received 1 bid for the Courthouse Security Project from M2 Automation and Control Services, Inc. After discussion, the Board took the bid under advisement for further review.

Scott Jensen from the Owyhee County Extension Office introduced Educator Surine Greenway to the Board. Ms. Greenway discussed upcoming classes and programs that she will be conducting with various local and state groups.


