Commissioner Aberasturi made a motion to table the resolution regarding the Marsing Ambulance Taxing District until the June 8, 2015 meeting. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the appointment of Robert Thomason to the Southwest District Board of Health. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve the Western Waste Services contract for the Three Creek area with a 30-yard roll off \$400 dump fee, \$35 per ton landfill fee and a monthly rental of \$500. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve the following 3 Retail Alcohol Liquor Licenses; Commissioner Aberasturi seconded the motion and it was approved.

License #26 for Fishers Saloon, License #27 for Del Rio Restaurant and License #28 for La Fogata.

Commissioner Aberasturi made a motion to approve a letter of support to the Idaho Emergency Medical Services Bureau for the Homedale Ambulance Service for a new ambulance and CombiCarrier grant. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve a letter of support to the Idaho Emergency Medical Services Bureau for the Grand View Ambulance Service for a grant for 12 defibrillators. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve the Justice Benefits contracts. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to go into closed session for Indigent and Charity matters. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Aberasturi made a motion to approve the certificate of denial for Indigent and Charity case 15-08. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Hoagland made a motion to approve a letter to the BLM regarding the monument placing approval process. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to approve a grant match in the amount of \$3000.00 for a feasibility study for the juniper projects grant. Seconded by Commissioner Aberasturi. Motion carried.

Commissioner Hoagland made a motion to go into executive session pursuant to Idaho Code 67-2345(1) (f) for possible litigation. Commissioner Merrick seconded the motion. Commissioner Aberasturi was not present. Merrick – aye, Hoagland - aye. Motion was unanimous. No action was taken.
