August 3, 2015

Present were Commissioners Merrick, Hoagland and Aberasturi, Assessor Endicott, Sheriff Grant, Indigent and Charity Director Evans, Prosecuting Attorney Emery, Planning and Zoning Director Huff, Tami Hedges representing New Environment LLC and Sean Chaney with the Owyhee Avalanche.

The Board took up old business; Marsing Senior Center request for funds in support of a vehicle purchase. Commissioner Aberasturi recommended looking at the allocation for all annual senior center support, citing that it would be best to increase all senior centers rather than singling one out for increased donations. The Board will review the budget and make a determination at a later date. Fish Pond Road discussion: Assessor Endicott and Commissioner Hoagland will contact Murphy Reynolds Wilson Fire Commissioners to inquire about any plans they have to expand and discuss possible easements.

Tami Hedges with New Environment LLC reported to the Board that the chemical cost my rise for next year's budget. Weed spraying will continue through the fall and Road Departments will contact New Environment directly when they notice noxious weeds along roadways that need to be sprayed.

Commissioner Aberasturi made a motion to place a lien on Indigent and Charity case 15-22. Seconded by Commissioner Hoagland. Motion carried.

Commissioner Aberasturi made a motion to approve Indigent and Charity case 15-18. Seconded by Commissioner Hoagland. Motion carried.


Commissioner Aberasturi made a motion to approve Indigent and Charity case 15-22. Seconded by Commissioner Hoagland. Motion carried.
